- A personal barrel selection session at the distillery
- The opportunity to purchase the selected single barrel

Alternatively, UK consumer can choose to select their barrel via samples at Buffalo Trace Distillery London tasting room experience to include:

• Private barrel tasting session guided by tasting expert

• The opportunity to purchase the selected single barrel and import the final bottled finished goods and empty barrel to the UK.

The opportunity to purchase is based on availability. Sazerac reserves the right to enforce limits on barrels at any time for any reason. The bottled finished goods and empty barrel will be imported to the UK. Purchaser will be responsible for the delivery cost from the Sazerac UK bonded warehouse to their residence.
